

Newbold Outdoor Recreation Committee Meeting

January 23, 2019 at 2:00 p.m.

The Newbold Outdoor Recreation Committee meeting was called to order by Chairman, Pete Cody at 2:06 p.m., on Wednesday, January 23, 2019 at the Newbold Town Hall, 4608 Apperson Drive, Rhinelander, WI 54501. Present were NORC members Jackie Cody, Pete Cody, Kim Gauthier and Ed Hammer, along with new committee member Kim Harron. The meeting agenda was properly posted on all three bulletin boards in the town.

Approval of NORC **meeting minutes** from November 29, 2018. *Motion made by Mr. Hammer and Mrs. Cody to approve the November 29th minutes. All in favor, motion carried.*

Discussion and possible action on the following:

New NORC board member. Interest was expressed by Mr. Kim Harron who has a background in directing YMCA camps for thirty-two years. Mr. Harron was present. *Motion made by Mr. Hammer and Mrs. Cody to favorably recommend appointment of Kim Harron to the town board as a member of the Newbold Outdoor Recreation Committee. That motion carried on a vote of all eyes.*

Possible 2019 **disc golf tournament** at NORA. Mr. Cody recommend a call be made to Duster, Mike Cuzzens and Tom Winsce to see if any are interested in coordinating a tournament at NORA. Mrs. Gauthier asked for clarification on the role of the committee and town for a tournament event. Discussion on possible facility fee, organizing parking and preparing the course for a tournament. Mrs. Cody will contact those indicated and ask if there is interest and what the tournament director would need and bring information back to the committee.

Storage building at NORA. Mr. Cody indicated he is waiting for formal confirmation from Blackwell Job Corp. to construct the storage building.

2019 outdoor event discussion on what is possible for this winter. Mrs. Gauthier would like to host a candlelight snowshoe hike, however the committee agreed this would be better suited for scheduling next winter and host a daytime hike this winter with only providing a warming fire or fire for those who want to roast hotdogs on their own. The committee would provide the fire and announce the event to the public. The date chosen was Saturday, March 2nd from 10:00 a.m. until 2:00 p.m. Disc golfing will also be open and available.

Suggestion box at NORA. Mr. Cody asked if the box has been considered at NORA as a post design or mounting to the kiosk. Mrs. Gauthier will discuss this further with the Public Works Department and report back to the committee.

Administrative review and discussion by the Newbold Outdoor Recreation Committee, if necessary concerning project updates and financial matters. The next meeting will be scheduled prior to the March 2nd event. The meeting adjourned at 3:07 p.m. on a motion by Mr. Hammer and Mrs. Cody with no objections.
