

## **Newbold Outdoor Recreation Area Committee Meeting**

**August 2, 2018 at 3:00 p.m.**

The Newbold Outdoor Recreation Committee meeting was called to order by Pete Cody at 3:00 p.m., on August 2, 2018 at the Newbold Town Hall. Present were Jackie Cody, Pete Cody, Kim Gauthier, Ed Hammer; Committee Members. The meeting notice was properly posted.

Discussion and action on approving Newbold Outdoor Recreation Committee meeting minutes of July 12, 2018. *A motion was made by Mr. Hammer and Mrs. Cody to approve the NORC minutes of July 12, 2018, as presented. That motion carried on a vote of all eyes.*

Discussion and possible action on the following agenda items:

Fundraising and donation box discussed. Mrs. Cody indicated another donation may be coming from the Oneida County Biking and Walking Council. Mrs. Gauthier and her daughter painted the donation tube donated by the DNR. A label will be printed and purchased from Hahn Printing designating the donation tube/box. Envelopes have arrived and the stamp for imprinting the envelopes is on order.

Commemorative Disc order arrived. Mrs. Cody presented some of the discs. Fifty had been ordered, however the committee requested blue and green which did not arrive. Mrs. Cody will request those colors from the supplier. They will be sold at the grand opening event.

Disc golf course work discussed. Mr. Cody indicated all tee pads have received additional work, the only fairway work left is on number seventeen. Others will need dragging and some debris clean up. Seeding of number five and gravel placement on number eleven. The doggie waste station will need to be placed and the kiosk sign stained. Mrs. Gauthier is working with Custom Wood Products on an engraved sign indicating the kiosk sponsor by Wayne Wagler Forest Products, Inc. A 24" long cedar sign will be approximately \$100 and attached to the kiosk. More information will be presented at the next meeting. The committee agreed to pursue the cedar sign and obtain recommendations from Mr. Kortenhof.

Discuss brochure, score card printing and tee-shirt printing. Mrs. Cody presented a sample brochure, score card and tee-shirt decal. The committee made a minor change and agreed to proceed with printing of the brochure and score card. Tee shirt designs will be researched and brought to the next meeting by Mrs. Cody.

Discussion on opening date and grand opening proposed by Mr. and Mrs. Cody of September 15, 2018 and October 6<sup>th</sup>. It was decided to present the dates to the town board and schedule a NORC meeting to just discuss the opening ceremony. That meeting was scheduled for August 20, 2018 at 3:00 p.m.
